What is your USP that makes you unique? What are industry trends? What will make your client react? What are you selling? (For e.g.: are you selling eyeglasses or vision?) What is your brand of product and services? What would be the price?

## The Main Factors of a Successful Venture

The starting up of a business brings upon some significant changes in the business owner's life:

- 1) the permanent financial freedom,
- 2) flexibility of schedule,
- 3) satisfaction of making one's life fulfilled- irrespective of making the business grow into a mammoth structure or just keep doing what you like to do and earn your living.

Beside the excitement of new ventures arrive the challenge of wearing too many hats- strategic planning, marketing, sales, production, customer support, accounting and financing. Even if the business is small the tasks are huge.

Whatever might be the field, the main factors of a successful venture remains the same-

- 1) a good idea,
- 2) an effective marketing plan that is not hugely expensive,
- 3) efficient operation.

### Ideas

A proper business idea is crucial for the success of the venture. Firstly you must be passionate about the area of work. Secondly you must posses enough knowledge, talent and experience to stick on. Finally, choose a business that'll yield small and steady income without heavy investment. This will eventually support you and your family. Some ideas that can be considered are- freelance writing, online marketing, web design, book keeping etc.

### Promotion

Basic tool of marketing your product and services would be distributing business cards. You can design the card yourself by using different business card templates but it would be wiser to spend some money and let a professional do it. As little as 20\$ will get you 500 cards.

Color cards are a bit more expensive. Next step is to build a website which will allow the prospects to view the information 24 hrs 365 days. Around 50\$ is the cost for web holding per year. Another 80\$ more would get you two simple web pages. If the internet prospects look good, then spend \$50 on pay-per-click (PPC) online ads. \$50 on PPC will bring you more customers and also generate revenue.

### **Operation efficiency**

Running the business (marketing, sale, production etc) takes away all the time for small business owners. They don't have time (or knowledge) on strategizing the expansion of the business. The result is that they either remain a small venture or get wiped out if there's a drastic change in the market.

Operation efficiency is even more required in smaller ventures than in established farms. Some methods of improving operation efficiency-

- 1) streamline business process,
- 2) utilize productivity software,
- 3) outsourcing and etc.

Some thing like- hiring an accountant for tax returns and bookkeeping, a collection agency for debt collection etc should be done. Always spend time in expanding your business.

### **Business Start-up Mistakes**

An economy primarily consists of producers and consumers, and they engage in what is known as transaction. An economic transaction would be the transfer of goods and services from the producers to the consumers in exchange for money.

Creation of goods involve various activities. These activities can be collectively known as a business, or a firm. Starting a business is neither easy nor quick. Here are a few essentials required to do the same.

### What to produce?

There are many goods that an economy consists of. Hence, the producer must decide on which of these to produce. Looking out for one's own profit cannot be the only criteria. Resources are scarce, and they should be used optimally and towards the societal welfare.

### How to produce?

There can be many methods of producing one commodity. Hence, the producer should opt for that process which exploits the resources fully at minimal cost.

### How much to produce?

An excess of supply will lower the price and the producers will eventually incur a loss. Hence, produce to cater to the market demand.

#### Capital

To start a business one needs to have enough investment power. If a producer does not have the required capital he can take loans from financial institutions, or enter into partnership with other investors to get collective investment support.

#### • Market Study

It is not enough to have the money to set up a business. One needs to understand the consumption patter of the market. Even if the product has high selling probability, it should be marketed in a way that it grabs the buyer's attention. Otherwise, consumers might not be fully aware of the product details.

#### • Scale of production

Normally, a business cannot reach the optimal production level in the short run. This is due to the fixed inputs of production that cannot be changed according to need. These inputs give rise to fixed costs which cut into the producer's revenue. However, with time as the business reaches a considerable scale, these fixed inputs disappear and only the variable ones remain, i.e. the producer faces only variable cost.

#### • Delegation of activities

No business can sustain on the basis of single showmanship. There are too many activities involved. Therefore, it is cheaper, more efficient and necessary to delegate duties to the individuals specializing in those fields.

Hence, violation of any of the above guidelines is a mistake through which the business suffers.

### **Entrepreneurship Myths**

There are a lot of myths about being an entrepreneur; most spawned by the media. While some these are true, others are patently false. The following are the top five myths:

#### • Myth #1: Entrepreneurs want money. Period.

A lot of people think entrepreneurs are in it solely for the money. This is true to an extent—fear of poverty, or simply financial insecurity, might well goad anyone to greater heights, and there are some who do it for the cash, but for most people, money is not the be-all and end-all.

A lot of entrepreneurs have ego and/or emotion as their primary motives, many don't maintain the lavish lifestyles expected of them, and most consider money as a way of keeping score.

#### • Myth #2: My gain, your loss.

People often refer to success in business at the cost of someone else. What they mean, obviously, is that if an entrepreneur is winning, someone somewhere has paid the price. This makes it seem like there has to be a winning and a losing side in every business deal. This is sometimes called the 'zero-sum game'.

In actual fact, entrepreneurs are creative thinkers. Rather than play for a 'zero-sum' result, and contrary to popular supposition, they often try to work out a compromise that means everybody leaves the table satisfied.

#### • Myth #3: The greater the risk, the greater the reward.

A lot of young entrepreneurs, having heard this, accept it as gospel truth. A relationship between risk and reward is complicated and in no way reducible to a simple statement.

Risks in business don't equalize jumping off a cliff in the dark: knowledge, experience, wisdom hard work and perseverance modify both the 'risk' and the 'reward'.

#### • Myth #4: Entrepreneurs get rich fast.

The rise of 'dotcom millionaires' definitely makes it seem like entrepreneurs make a quick buck, but you should remember nothing is as easy as it seems.

You may think that entrepreneurs get extremely rich extremely fast, but a lot of hard work goes into developing the ideas/products that make them rich.

#### • Myth #5: <u>A good business plan is the entrepreneur's critical roadmap to success.</u>

This has more truth than most of the other myths, as you're unlikely to be given loans without a solid business plan. However, a loan does not in any way equal good money. Business plans are guidelines, yes, but to succeed, you need a lot more.

### **Ethics in Business**

"Honesty is the best policy", a phrase that is valid not only in one's daily lives, but also in business ethics.

Ethics are very important to all business people. Yet, many neglect ethics as an important concept that has a major impact upon a person's success as an entrepreneur and investor. Business, after all, involves dealing with money, either one's own or borrowed.

It also involves building successful money based relationships with clients and customers. Such relationships must be built on trust – and having ethical foundations are imperative to the building of trust. Therefore ethics constitute the cornerstone of success in business.

It is important to realize that ethics is important irrespective of the size of the business. Whether your business enterprise is large or small, whether your customers are many or few, the relevance of adhering to high ethical standards is the same.

You see, ethics in business is closely linked to the moral value chain that intertwines through all its operations. Moral value impinges on every single customer. There can be no exceptions irrespective of whether your customers are 10 or 10,000 in number or more. Ethics apply to each of them.

As a discipline, ethics in business can be either applied or theoretical. Or to express it differently, it can be either pragmatic or philosophical. The former evolves, typically, into the do's and dont's that act as guidelines to achieving ethical behavior. The latter studies involve probing the whys and wherefores of ethics in business. It also examines the issue of defining ethics.

It promotes high standards, draws up a code and helps the entrepreneur self-evaluate his own personal ethical standard. This standard in turn helps the business enunciate the norms of ethical behavior of its employees. An honest business employs only honest professionals. This must be clearly understood down the line.

In most successful business organizations high ethical standards are compulsory. An employee bribing somebody, even to further his employer's interests, is likely to be dismissed. Many multinationals refuse to conduct business in countries where bribes are commonly given and taken. These are examples of the applied side of ethics in business.

Whatever is communicated, whether to the customers or the employees, must be carefully crafted in order to attain the goals that have been set.

If you focus on your target segment's needs, you are likely to be able to set up an effective communication strategy. They care about your goals, but only o far as they benefit from it. So identify with their needs and communicate your goals in terms they empathize with.

It is advisable that you get a loan only if you can generate enough sales to pay the loan back. If your business is not doing very well during the first year then you might want to shut it down.
